Support for Israel is strong on both sides of the aisle. This past year the US has given more military aid to Israel than at any previous time. Iron Dome, funded largely by the US, was able to divert missiles shot from Gaza. The US has forcefully opposed the PA's unilateral bid for statehood and stood by Israel when the PA gained membership in UNESCO.

Women, their reproductive rights, health and contraception were the targets of the conservative agenda and HHS Secretary Sebelius' inexplicable decision to overrule the FDA regarding emergency contraception.

Separation of religion and state has become entangled with Choice. The Catholic Bishops are pressing for a wide exemption in the new health care exchanges which would allow their affiliated institutions to refuse to cover contraception or abortion. This would subject thousands of women employed by universities or hospitals (that receive federal funds) to Church doctrine.

2011: STRONG US-ISRAEL TIES

- President Obama, at the U.N. General Assembly and numerous times before and since, in front of friendly and unfriendly audiences, has reiterated his commitment to Israel's security and to the bonds of friendship between the United States and Israel. Israel's Defense Minister Ehud Barak told Fox News, "Our countries are good friends. I can hardly remember a better period of support...cooperation...and similar strategic understanding of events around us than what we have right now."

- President Obama led the funding effort for the Iron Dome missile defense system and committed to Operation "Juniper Cobra" – a joint military exercise to strengthen coordination between US and Israeli missile defense systems, planned for 2012.

- On September 8, Undersecretary of State for Political Affairs Wendy Sherman testified that the Obama Administration would veto a resolution supporting a unilaterally declared Palestinian state. The US worked behind the scenes to convince members of the U.N. Security Council that the Administration's position – that statehood can be achieved only through direct negotiations – is correct. Consequently, a resolution never came before the Security Council.

- The administration has consistently supported the foreign aid package to Israel, rebuffed any efforts to decrease or revise the current ten-year plan and has spoken against attempts to delegitimize the state.

Situations arise – ones that are non-security related – that simply call for friends taking care of friends in need.

- Israel's Ambassador to the United States, Michael Oren, praised President Obama in a recent interview with *Israel Hayom*. "About a year ago when the fire broke out in the Carmel forest...I went to the White House, late in the evening and asked to meet with the President. Obama

REPRODUCTIVE RIGHTS

The 2011 War on Women is at a critical juncture: Plan B restrictions, abortion coverage denied for military women, Prenatal Nondiscrimination Act, Catholic Church opposition to contraception coverage, HR 3 - No Tax Payer Funding for Abortion Act, HR 358 - Protect Life Act, HR 1 - strip funding from Planned Parenthood, elimination of Title X funding, end of funding for abortions for low-income women who live in DC, S1005 - requirement of abortion providers to notify parents by mail if their minor daughter seeks an abortion, HR 1216 - bar medical teaching centers from teaching abortion care. These examples, paired with laws around the country that are aimed at limiting women's reproductive choices, have made 2011 a terrible year for women's reproductive rights.

With joblessness at record high levels, two wars, and global upheaval, Congress has decided to devote its legislative energies to women's reproductive rights. A majority of the House voted to let women in emergency situations die in order to respect the religious beliefs of doctors who refused to perform life-saving abortions. More recently HHS chief Kathleen Sebelius rebuked the FDA and ruled against over-the-counter access to Plan B. Catholic Bishops are lobbying to ban contraception coverage from insurance plans.

Not all is lost though. Voters have rejected the most egregious measures such as personhood referenda in two states. President Obama's health care bill will provide contraception for women without co-pays. He lifted the global gag rule. Senators have introduced laws to repeal ineffective and incomplete abstinence-only education. Planned Parenthood has maintained its federal funding. The US Senate has not allowed anti-choice bills from the House to become law.

A pro-choice Senate and a pro-choice President are all that stand between anti-choice lawmakers and repeal of

was in the middle of a party...I told him that a huge fire was raging in the Carmel...Obama called a senior advisor and ordered: 'Whatever Israel wants, get it to Israel right now.' The next morning, representatives of the American firefighters presented us with eight Hercules planes." Oren also

recounted that the administration's response to rescuing the Israeli Embassy team in Cairo was identical. When PM Netanyahu called the President late on a Friday night to say, "I need you," the President took immediate action and the Israeli team was evacuated safely. Friends sometimes disagree and mis-

understandings occur, but in the areas that count, the US-Israel relationship is as strong or stronger than ever, The generals speak often, the President doesn't hesitate to express his commitment and Israel's Prime Minister knows he can count on Washington when needed.
